# Management/Executive /Finance Committee Meeting

## (Dated: 13th December, 2022)

The following agenda items were taken up in the meeting of the Management /Executive /Finance Committees held on 13<sup>th</sup> December,2022 under the chairmanship of Dr. Prajya Mishra in the conference hall of the college.

The decision taken in the Executive/Finance committees meetings held on 23/03/2022,01/08/2022 and 20/08/2022 and the minutes of the previous meeting of the Management committee held on 05/03/2022 were unanimously approved in the meeting. After the approval the agenda items of the meeting were taken up.

## Agenda item: 1

- In the meeting the guidelines issued by the Govt. of Himachal Pradesh vide letter no. EDN-HE-(8)A(1)-69/89-2020(S.F.Fund) dated 17<sup>th</sup> October,2022 were unanimously adopted.
- As per the guidelines all the powers regarding recruitment and services of the persons
  engaged through the society will remain with the Management committee of the society
  and the Governing body will be responsible for all the service related matters of the staff
  engaged.
- The eligibility criteria will be as per the guidelines of the UGC/AICTE/HPU/ H.P. Government.
- 4. Teaching incumbents will be appointed initially for a period of three years on period basis @ Rs. 250 per period for every one hour period(to be reduced proportionally if the duration is less than one hour) with maximum limit of Rs. 15000/- per month subject to availability of funds.
- Only properly qualified staff, engaged by following the proper procedure, is entitled for the honorarium at the above mentioned rates. No under qualified staff is to be engaged for the teaching courses.
- After three years the consolidated salary of the eligible teachers will be fixed at Rs. 21600/- per month subject to the availability of the funds.
- An annual increase of 5% in the consolidated salary will be given after completion of one year without any other allied benefit subject to availability of funds.
- 8. The employees who have completed 7 years or more as guest faculty(teaching and non teaching) and fulfill the requisite eligibility qualifications will be placed equal to the emoluments of contractual employees subject to the availability of funds. The emoluments will be given as per the letter number Fin©-B(7)-2/2021 dated 12/01/2022 from Govt. of Himachal Pradesh.
- 9. The eligible staff engaged under the society will be entitled for half month paid vacations and leave as admissible to contract employees. The leave shall not be carry-forwarded to the next year. The persons engaged under self financing scheme may be entitled for the salary/remuneration for 12 months in a financial year subject to availability of funds.
- 10. For the staff members (Teaching and non teaching) whose cases regarding their services are pending in the hon'ble High court and the matter is sub-judice, it was decided that the status quo will be maintained in all such cases till the final decision from the court or the withdrawal of cases by the incumbent whichever is earlier.
- 11. It was also decided that an academic calendar will be prepared for the staff working under the Society with 15 days break period. This period will be treated as the break period(without pay) for the incumbents whose cases are pending in the court as per the existing norms and paid holidays for all other employees.
- 12. The decision regarding the benefits such as EPF etc will be considered after consultation with the concerned departments/Higher authorities and subject to the availability of funds.

- 13. The salary/remunerations hike will be effective with effect from 1st January,2023 and the date of increment will be after completion of one year service.
- 14. Audit of the funds will be done after the completion of every financial year.

## Agenda item: 2

On the request from the Librarian it was decided to appoint one library bearer/Assistant
on the honorarium (@ part time daily wages) as per Govt. approved rates after
observing all the codal formalities. The salary will be given out of society funds.

## Agenda item: 3

1. The last enhancement in the remunerations of the part time staff of the Society was done four years back on 21/08/2018. In the meeting it was decided to enhance the remunerations of all the part time staff members of the society with effect from 1<sup>st</sup> January, 2023 as per the following details:

## Agenda item: 4

It was decided in the meeting that Institutional level scholarship @ Rs. 5000/- per annum may be given to students securing first position in the college in the University examinations of B.Sc./B.Com/B.A. 1<sup>st</sup> year and first position in first two semesters (Combined) in case of BBA and BCA out of society funds under the name 'PALAM SOCIETY SCHOLARSHIP' with effect from 1<sup>st</sup> January,2023.

#### Agenda item: 5

1. The IQAC of the college has recommended to create email id's with the domain name of the college i.e. ----- @gcpalampur.ac.in for the teachers of the college which is required for accessing online research journals and academic resources ,for which recurring funds are required. It was decided for the time being one e mail id in the name of the Principal may be created and the credentials of this mail can be shared with the staff members. The expenditure in respect of that mail id can be done out of the society funds.

 A request for sanctioning of funds for the organisation of Conferences/workshops/seminars in the college was raised in the meeting .The chairperson was empowered to sanction an amount of Rs. 25000/-(Seed money) per event, subject to maximum of two such events per academic session out of Society fund
